*** PALLET FEE MUST BE ADDED FOR ALL LOOSE PACKAGING. WAREHOUSE WILL CHARGE PALLET FEE IF CARGO ARRIVE TO CFS AS LOOSE PACKAGING.

*** MAKE SURE TO CHECK THE MAP PRIOR TO USING THE QUOTATION SYSTEM TO ENSURE THE DELIVERY ADDRESS IS A COMMERCIAL AREA WITH LOADING DOCK. IF NOT, PLEASE CHOOSE THE CORRECT OPTION SUCH AS LIFT GATE REQUIRED, RESIDENTIAL DELIVERY, ETC...

*** IF APPOINTMENT FOR DELIVERY IS REQUIRED, THERE WILL BE AN APPOINTMENT FEE.
